Investment programme description	The Investment Programme concerns implementing battery electric and fuel-cell electric buses, electric vehicle (EV) charging and hydrogen refuelling infrastructure, implementing an electric ferry service, and park&ride (P&R) facilities in Ljubljana.
Investment amount to be mobilized	EUR 65,985,492.00
Description of the approach to implement the Investment Programme	The Investment Programme will be implemented by a new Project Implementation Unit (PIU) in the period 2024-2028 in phases structured along the project components. The PIU will involve existing LPPs divisions and City of Ljubljana's municipal departments responsible for the investment's implementation, and external experts.

The total estimated contributions are:</p> <ul style="list-style-type: none"> • Estimated annual reduction of NO_x reductions (and/or other pollutants and particulates) - Annual total reductions of 22.65 NO_x t • CO₂ reductions -Annual total reductions of 8,835 t CO₂ eq <p>The Investment Programme is expected to create employment. It will create 489 FTE during project construction.</p> <p>The Investment Programme will also be an example of implementing river electric transport systems. From this perspective, the project is assessed as having high impact in terms of deploying 'new to market' goods and services.</p>
